Law and Regulation Regarding Internal audit

Regulation 6 of the Accounts and Audit (England) Regulations 2011 imposes a duty on local councils to 'maintain an adequate and effective system of internal audit of its accounting records and of its system of internal control in accordance with the proper practices in relation to internal control. Internal audit is a key component of the system of internal control.

The purpose of internal audit is to review and report to the council whether its systems of financial and other internal controls over its activities and operating procedures are effective.

Internal audit's role is to assist the council in fulfilling its responsibility to have and maintain proper internal control arrangements and those for the prevention and detection of fraud, error or mistakes

All internal audit work must be reported to the council. Any report by internal audit is addressed to the council, may recommend actions to be taken by the council, and should be treated as a document open to view by local taxpayers.

Two pieces of legislation set out how local councils should behave when accounting for the public funds they manage and what rights local taxpayers have in relation to those accounts. These are the **Audit Commission Act 1998** and the **Accounts and Audit Regulations issued from time to time under the Act**. The requirement for local councils to prepare accounts annually and to subject them to external audit comes from the Audit Commission Act 1998 (the Act). The Act describes the rights of taxpayers and other interested parties in relation to those accounts.

Under the regulations, all local councils must at least once a year conduct in accordance with proper practices a review of the effectiveness of their system of internal control and publicly report the outcome. The Annual Governance Statement in Section 2 of the annual return provides the means for local councils to report to local taxpayers on their system of internal control.

This report is prepared for the council and proper officers of the council named above, for use in fulfilling their obligations under the Audit Commission Act 1998 and the Accounts and Audit Regulations issued from time to time under the Act for preparing the Annual Return and reviewing the effectiveness of their system of internal controls. Mulberry and Co accept no responsibility for any action or inaction taken as a result of the findings of this report and accept no responsibility to any other party other than those named above.

Summary Findings

I enclose my final report for your kind attention and presentation to the council. I am pleased to report that overall the systems and procedures you have in place are entirely fit for purpose. I am therefore pleased to report I can sign of the annual return positively.

My audit was conducted in accordance with current practices and guidelines and testing was conducted in line with the inherent risks assessment. Whilst I have not tested all transactions, my sample has where appropriate has covered the entire year to date. Amongst others the following areas were covered in my testing:-

- Review of the Financial Regulations & Standing orders
- Review of the Risk Assessments
- Review of the Budgeting process
- Proper Bookkeeping review of the use of the accounts package.
- Review of Income
- Review of Salaries
- Review of Fixed Assets
- Review of Annual Accounts

A. BOOKS OF ACCOUNT

The manual system of recording the financial transactions of that of the council was logically presented and easy to follow and understand. The limited number of transactions lends itself to a simple cashbook style of presentation and on this basis I make no recommendation for change at this stage.

B. FINANCIAL REGULATIONS

Financial regulations and standing orders are based on the NALC models – these were reviewed in the 2016 year. Evidence was seen to show council is following regulations and proper practices. No S.137 in year. I reviewed the minutes for two consecutive months and was able to prove council is approving all payments in the cashbook with no cut off errors, that cheques are initialled twice and clear referencing leads to the underlying supplier invoice. I make no recommendation for change at this stage.

I am of the opinion council has followed regulations.

C. RISK MANAGEMENT & INSURANCE

Council is insured with Hiscocks via Came and Company on the three year standard local authority deal. Money and asset cover appear to be adequate.

The council is in the process of updating risk assessments and internal policies. These are presented in tabular and written format which will be taken to council in July 2016.

I am of the opinion the council is considering risk and insurance in accordance with regulations.

D. BUDGET & PRECEPT

The council has £13,451 (2015: £17,385) in reserves, of which £6,200 is general reserves; council is aware that it has no power to accumulate general reserves and at a precept level of £12,400 this would not be regarded as excessive. The earmarked balances are for elections and extra work vis new developments.

Budgets were drawn up in the correct timescale and are reported on, for the 2016/17 council year the precept has been budgeted at £12,400 for the second year. In total, the 2016/17 budget is a breakeven budget and it is anticipated that reserves will remain at circa £13,500 by the end of the year.

I am of the opinion budgets and precepts are correctly calculated.

E. INCOME

The council has precept, grant, and interest income. The precept and local tax support grant were tested to third party remittance advice notes – there were no errors and income is correctly shown on the annual return.

Other income grants were tested to documentary evidence and or bank statements as applicable. There were no errors.

I am of the opinion income is correctly shown on the annual return.

F. PETTY CASH

No petty cash

G. PAYROLL

Payroll is calculated by West Sussex County Council for which a charge is made. Payments as shown in the cash book reconcile to the payroll records. Payment to the clerk was in accordance with regulations. Clerk is paid a regular amount each month and this is approved by council in the normal payments run at full council.

I am of the opinion the wages cost per the annual return is correctly stated.

H. ASSETS AND INVESTMENTS

The council has £16,056 (2015: £15,250) of fixed assets. In year the notice board was replaced and a new computer purchased. Fixed asset register lists the assets in simple form showing original cost, location and comments regarding insurance.

I am of the opinion that fixed assets are correctly shown on the annual return.

I. BANK RECONCILIATIONS

The council has two bank accounts and at the year-end there are £13,451 of reconciled reserves. The year-end reconciliation was correct with no adjustments. Council has a good system on internal review and presentation and I make no recommendation for change at this stage.

I am of the opinion bank and cash balances are correctly shown on the annual return.

J. YEAR END ACCOUNTS

These were correctly prepared on the receipts and payments basis. The annual return correctly casts and amounts could be traced back to the cash books.

I am of the opinion the accounts are ready for submission to the external auditor.
